Tuesday, May 6: Public Hearing on FY 2015 Proposed Budget

Weeks of May 12 & 19: Budget Work Sessions—Discussion of Public Hearing comments as necessary

Tuesday, June 3: Adoption of FY 2015 Budget and Appropriation of Funds at June Town Council meeting

Earning the Grants



The Town applies for and is in receipt of grants periodically, with the most recent awards being for several mobile data terminals (MDTs) for police vehicles, police vehicle equipment,

and street trees for the continuation of the street tree planting project (South Main Street).

MDT Grant: Having the MDTs enables our officers to input incident data immediately, which increases officer efficiency and allows for improved access to important information. We are partnering with the Town of New Market for the purchase of the computers, which will lower the costs associated with the project and will increase the number of computers we can buy.


Police Vehicle & Equipment Grant (USDA Rural Development): The Town has received money toward the purchase of a police vehicle and police safety equipment (radio, light bar, graphics, etc.).

Tree Planting Grant (USFS Chesapeake Watershed Forestry Program): The street tree planting project will include the planting of over 30 street trees along South Main Street and the maintenance or removal of heavily utility-pruned trees. Staff and Tree Board members will be participating in a tree assessment work session, which will allow our team to decide on the "right tree for the right place." (Spring planting.)

W.O. Riley Park Revitalization Project

We are preparing to break ground on the W.O. Riley Park Revitalization Project! Bids are due back to the Town on February 4. For a large cost-savings, our Public Works crews will be doing most of the demolition associated with the project, which includes areas of concrete and asphalt removal, as well as the removal of our beloved playground. Many of our citizens participated in the construction and coordination of the existing playground and while the project was a source of community pride, it has outlived its useful life.

We are excited to have a playground that will include the following components: a colorful post and deck play structure, a rubberized safety surface, a natural play area and outdoor play "kitchen," a low-flow water feature, berm slides and tunnel, a group swing, individual swings, landscaping, and a large play web.
